Such Demand draft is to be enclosed with the tender in a separate envelope; duly superscribed as **EMD FOR THE WORK OF CONSTRUCTION OF COMMON ROOM UNDER RUSA GRANTS FOR STUDENTS OF GVM'S DADA VAIDYA COLLEGE OF EDUCATION FARMAGUDI, PONDA- GOA**

Earnest money deposit in any other form including hard cash shall not be accepted.

The intending tenderers applying for the above work shall have to fulfill the below mentioned **Eligibility Conditions**:

1. The contractor should have satisfactorily completed one work costing minimum of **Rs. 50 Lakhs** or two works costing each work of minimum **Rs.25 Lakhs** or three works minimum of **Rs.15 Lakhs** each. Certificates of satisfactory completion of works shall have to be appended with application form.
2. The Contractor should have valid registration with **EPF, ESIC and GST** as on the date of application. In the alternative if the contractor engages a labour sub contractor to employ necessary skilled, unskilled and specially skilled workmen, then the Contractor shall be in agreement with the labour supply agency registered under **Labour Contract Act** and that **PF and ESIC** contributions will be paid to authorities and receipts submitted in time. Attested copies of all above registration certificates shall be attached with application form.
3. Individuals or agencies applying for the above work should produce permanent account number (PAN CARD) issued by the Income Tax Department in the name of firm or Individual (in case of Proprietor) duly attested by Gazetted Officer along with the application.

All relevant documents as above should be enclosed along with the application to be eligible to obtain tender form.

The calendar of tender process is as here below:

- 1. Last date of application : 21 /06/2023**
- 2. Last date of payment up to 1.00 p.m. : 28 /06 /2023**
- 3. Issue of blank tender papers up to : 05/07/2023**
4. The tenders of those contractors who do not remit the **earnest money** in the prescribed mode are liable to be rejected. No way will any request to the effect that EMD will be furnished on the last date be entertained. No bank cheque will be accepted under any circumstances. Right to reject any or all the tenders without assigning any reasons whatsoever is reserved with the authority competent to accept the tender.
Incomplete applications will not be responded to.
